Female Peer Advocate Job Description

Objective of position: Our mission is to equip woman and their families with unplanned pregnancies to make life affirming and informed choices by using biblically based principles and to demonstrate the unconditional love of Jesus Christ

Qualifications:

- A commitment to Jesus Christ as Lord and Savior.
- Faithful attendance in a local church
- Agreement with the PRC Statement of Faith and Mission Statement
- Dependable, capable of confidentiality and able to follow instructions.
- Emotionally healthy an handle additional pressure
- Completion of PRC volunteer training
- Commitment to adhere to all policies and procedures
- Faithfulness and confidence in the Word of God with an ability to communicate its truth.

Job Description:

The term “Advocate” does not suggest to either the volunteers or clients meaning such as a professional counselor, therapist, or even one who tells others what to do. A PRC Advocate is a facilitator who assists the clients to make an informed and autonomous decision by the following:

- Careful listening and communication skills
- Providing the client with factual and accurate information
- Providing the client with discussion opportunities in a caring environment
- Providing the client with decision-making and problem-solving assistance as the client processes the various factors necessary to make an informed decision.

Time Commitment:

- A one-year commitment of service from the training seminar conclusion
- A one four-hour shift each week
- Volunteer in-service meeting four to six times a year
